

ORDINANCE NO. 2004-2

AN ORDINANCE OF THE TOWN OF MILL CREEK, OKLAHOMA, RELATING TO FINES AND PENALTIES AND DECLARING AN EMERGENCY.

BE IT ORDAINED by the Town Council of the Town of Mill Creek, Oklahoma, as follows:

SECTION I. New Law.

A new section of law to be codified in the Code of Ordinances of the Town of Mill Creek in Chapter 10, Article I Fines and Penalties. The following fines and penalties shall be assessed for violations of the provisions of Chapter 10 of the Town of Mill Creek Code of Ordinances:

The fines for the following traffic violations shall be as follows:

All taxes due state .....	\$100.00
Attempting to elude.....	\$200.00
Careless driving .....	\$150.00
Driving left of center of roadway.....	\$100.00
Driving or A.P.C. of MV while impaired .....	\$200.00
Driving with an alcohol concentration of 0.10 or greater .....	\$200.00
Failure to remain at personal injury accident.....	\$200.00
Failure to remain at property damage accident.....	\$200.00
Failure to maintain or possess valid security insurance verification, driver.....	\$100.00
Failure to maintain or possess valid security insurance verification, owner .....	\$100.00
Failure to signal, improper turn .....	\$75.00
Failure to signal, improper lane change.....	\$75.00
Failure to stop at control device, sign/signal .....	\$100.00
Failure to submit vehicle for inspection.....	\$75.00
Failure to yield .....	\$100.00
Following to closely.....	\$100.00
Headlight or taillight violation.....	\$75.00
Improper backing.....	\$75.00
Improper passing in a marked zone .....	\$75.00
Operating and MV in a manner not reasonable and proper .....	\$240.00
Operating an MV while under suspension.....	\$250.00
Operating an MV without valid driver's license.....	\$110.00

Permitting an unauthorized person to operate a motor vehicle.....	\$150.00
Reckless driving.....	\$300.00
Speeding 1-10 mph over posted speed limit.....	\$90.00
Speeding 11-20 mph over posted speed limit.....	\$110.00
Speeding 21-30 mph over posted speed limit.....	\$140.00
Speeding 31-40 mph over posted speed limit.....	\$170.00
Speeding in a school zone.....	\$150.00
Transporting a loaded firearm in MV.....	\$75.00
Transporting open container of alcoholic beverage.....	\$150.00
All other violations.....	\$240.00
Possession of Marijuana.....	\$340.00
Possession of Drug Paraphernalia.....	\$300.00

SECTION 2. Severability.

If any section, subsection, sentence, clause, phrase, or portion of the Ordinance is, for any reason, held invalid or unconstitutional by any court of competent jurisdiction, said portion shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portion of this Ordinance.

SECTION 3. Emergency Clause.

Whereas an emergency exists for the preservation of the public peace, health, safety, and welfare, by reason whereof this Ordinance shall take effect immediately upon its passage and approval.
